### **Cookie Notice**

**ITW Electronics Assembly Equipment** (“ITW EAE”, “we”, “our”, or “us”) respects your personal privacy and is committed to adhering to the applicable privacy and data protection laws and industry guidelines, including the EU General Data Protection Regulation (“GDPR”). ### **Cookies**

To make this website simpler to use and navigate, we sometimes place a small data file on your computer or device. These are known as cookies. Most websites you visit will use cookies to improve your user experience by enabling that website to ‘remember’ you, either for the duration of your visit (using a ‘session cookie’) or for repeat visits (using a ‘persistent cookie’).

Cookies do lots of different jobs, like letting you navigate between pages efficiently, storing your preferences, and generally improving your experience of a website. Cookies make the interaction between you and the Website faster and easier. If a website doesn’t use cookies, it will think you are a new visitor every time you move to a new page on the site – for example, when you enter your login details and move to another page it won’t recognize you and it won’t be able to keep you logged in.

- Enhancing personalization, for instance, by remembering information you've given (such as a Zip or Postal Code) so you don't need to keep re-entering it
- Measuring performance of the Website and tracking how you use our Website so we can improve it to meet your needs
- Enabling targeted advertising so that advertisements better address your unique interests
